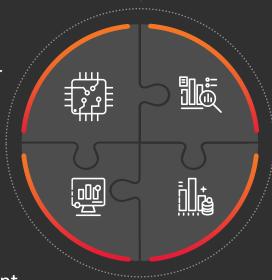


SiC Power Semiconductor Value Chain Development

 - Mass production facility in Busan to begin operation in April

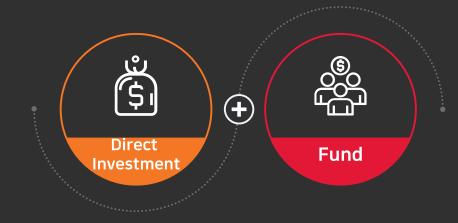
